CDC Recommends Booster Dose of Pfizer
COVID-19 Vaccine for Certain Populations and
Those in High-Risk Settings

On September 24, 2021, the Centers for Disease Control and Prevention (CDC) endorsed the Advisory Committee on Immunization Practices (ACIP) recommendation for a booster dose of the Pfizer-BioNTech mRNA COVID-19 vaccine in certain populations and recommended a booster dose for those in high-risk occupational and institutional settings.

This booster dose recommendation does not apply to people who received the Johnson & Johnson/Janssen or Moderna COVID-19 vaccine.

The CDC recommends the booster dose for individuals who have received the Pfizer-BioNTech mRNA COVID-19 vaccine:

- People 65 years and older and residents in long-term care settings should receive a booster shot of Pfizer-BioNTech's COVID-19 vaccine at least 6 months after their Pfizer-BioNTech primary series,
- People aged 50 64 years with <u>underlying medical conditions</u> should receive a booster shot of Pfizer-BioNTech's COVID-19 vaccine at least 6 months after their Pfizer-BioNTech primary series,
- People aged 18 49 years with <u>underlying medical conditions</u> may receive a booster shot of Pfizer-BioNTech's COVID-19 vaccine at least 6 months after their Pfizer-BioNTech primary series, based on their individual benefits and risks, and
- People aged 18 64 years who are at increased risk for COVID-19 exposure and transmission because
 of occupational or institutional setting may receive a booster shot of Pfizer-BioNTech's COVID-19
 vaccine at least 6 months after their Pfizer-BioNTech primary series, based on their individual benefits
 and risks.

West Virginians who meet CDC eligibility recommendations are strongly encouraged to choose COVID-19 vaccination, which now includes a booster dose for the Pfizer mRNA vaccine.
